1. OPENING REMARKS

The Chair welcomed everyone providing an overview of D&S highlights since the last meeting including:

- 24 February 2023 marked the one year since the illegal invasion of Ukraine by Russia.
- The Emergency Act Parliamentary Inquiry Report was released in February.
- Retirement of the RCMP Commissioner and announcement of interim Commissioner Michel Duheme.
- Announcement of the new CAF Housing Benefit Policy and CAF economic increase on 21 March 2023.
- Federal Budget announcement on 28 March 2023.
- Nova Scotia Mass Casualty Commission Report was released on 31 March 2023.

2. ADMINISTRATION POINTS

The previous minutes were reviewed and approved by the Committee.

3. RCMP UPDATE – Comrade Brendan provided the following updates:

Commissioner Brenda Lucki retired and an Interim commissioner has been appointed – Michel Duheme. Mr. Duheme was the Deputy Commissioner of Federal Policing prior to assuming the interim commissioner role.

There has been the release of two Commission reports:

- The Report of the Public Inquiry into the 2022 Public Order Emergency
- The Nova Scotia Mass Casualty Commission

Both Commissions have submitted their findings and the recommendations are being reviewed by the RCMP. The Commission reports are specific to each incident and speak to the health and welfare of RCMP members in terms of some recommendations for practices, policies and equipment. There is a residual impact on the membership at large because these were traumatic events, although significantly different in nature. The RCMP Veterans Association has written letters of support for the Members and positive acceptance of the recommendations.

- **4. VSS UPDATE** Comrade Carolyn provided an update on VSS Committee activities including:
 - a. Disability Wait Times VAC has been making progress on reducing the backlog of disability claims and it is expected that it will be cleared up by the summer of 2023. The Committee continues to monitor delays resulting from the public service strike and is concerned that it may slide backwards if the strike continues.
 - **b.** The Legion is meeting with the Minister of Veterans Affairs and the Deputy Minister on Thursday (April 27) and will highlight the Legion's advocacy issues.
 - c. Vocational Rehabilitation Third Party Contract Partners in Canadian Veterans Rehabilitation Services (PCVRS). The Legion is still monitoring the implications of this new contract. At this time, Veterans Services hasn't received any complaints but are closely monitoring the transition to the new third-party service provider.
 - d. Veterans Experiencing Homelessness Comrades Larry Murray and Carolyn went to opening of the Veterans Village Legion in Surrey, British Columbia. There are 91 affordable housing units, and the model is impressive in what it offers in terms of integrated health services and housing affordability.
 - e. BSO Legion OSI Special Section There is concern that the RCMP appears to lag behind the CAF in terms of Mental Health support and this an issue that the VSS Committee is looking into.
 - f. Legion Support to RCMP Veterans Some RCMP members are filling out their own VAC disability claims not knowing that the Legion offers this service free of charge. Veteran Services continues to outreach to offer their services and Membership will engage the RCMPVA again.
 - g. The Burns Way (TBW) Initiative TBW Initiative is an online Peer Support program for Indigenous Veterans using an APP called the Talking Stick. It is now being used in Saskatchewan but there are plans to expand across the country and to other Veteran communities. Comrade Carolyn confirmed a letter of support for the Initiative has been sent to the Minister of Veterans Affairs. A briefing from TBW on the initiative will occur at DEC.

h. Command Service Officer Stats for 2022 – First applications submitted by Command Service Officers increased 12% from 2021 to 2022 and the number of VRAB appeals and RfRs completed have increased by 17%. However, Departmental Review and VRAB Entitlement Reviews have decreased due to the VAC backlog.

5. UPDATES

a. WiDS Breakfast on 2 March 2023.

Over 1,000 women attended from across the defence and security community including government and the private sector including virtually from the Canadian Embassy in Kiev. The Legion sponsored a table and Comrade Dean will work with Marketing to sponsor again next year.

b. CDA Update

- 8 March 2023 CDA AGM was held. The Legion will continue to be represented on the Board for one more year.
- 8 March 2023 CDAI Ross Munro (a World War II journalist) Media Award presentation. Sharon Adams from Legion Magazine was the 2023 recipient recognizing her lifetime of work supporting Veterans.
- 9 10 March 2023 CDA Defence and Security Conference. Comrades Dean and Andrea attended the 2-day conference which covered current defence and security issues including the war in the Ukraine, Indo Pacific region, Arctic, Climate Change etc. The highlight was the CDS and VCDS presentations providing overviews of the state of the CAF. The Legion also had a display booth with a Service Officer providing information about the support provided by Veterans Services.

c. 150th Anniversary of the RCMP and Definition of Veteran

A second letter was sent on 7 February 2023 to the Minister Veterans Affairs. No response has been received.

d. High Cost of Housing

The CAF Housing Differential (CFHD) Policy was announced on 21 March 2023 replacing the Post Living Differential (PLD) benefit effective 1 July 2023. The aim of the CFHD is to ensure that CAF members who are renting or purchasing primary residences on the economy will only pay 25% of their gross monthly salary towards their housing cost. The amount of the benefit is based on salary and geographic location. If members are in single quarters, they won't receive the benefit but can ask to have their rent reduced to 25% of salary. Members can only receive the benefit for seven years if in the same location and it is based on the cost of a two-bedroom house. The amount of the benefit will be evaluated every year. The Legion released a statement on the benefit.

e. Chief Justice Louise Arbour Report on Sexual Misconduct in the CAF – What's next?

The Committee is waiting for the recently appointed Independent Monitor to provide feedback on the status of the implementation of the recommendations.

f. Budget 2023 - Impact on CAF and RCMP

Budget 2023 was announced on 28 March 2023. It did not include any new significant funding for the DND/CAF, however it proposed \$49 million over three years to help the RCMP protect Canadians from harassment and intimidation by foreign governments. It also provided \$13.5 million over five years starting in 2023-24 and \$3.1 million ongoing to Public Safety Canada to create a National Counter-Foreign Interference Office. The Committee will monitor the implementation of these initiatives.

8. **NEW ITEMS**

- a. Comrade Andrea provided information on the CAF Economic increase which was announced at the same time as the housing benefit 10.5% over 3 years.
- b. The Committee discussed the recent announcement by the Ontario government of new rules to protect jobs of Military Reservists who have been injured during deployments. Comrade Carolyn to discuss with the VSS Committee and look at how to engage with the other provinces.
