## 10. BRANCH SDERVICE MEDAL

Branch Service Medal is intended to be awarded to a member providing outstanding service and not a member of the executive committee. Although this is the intent it may also be awarded to members previously in receipt of awards for additional exemplary service. Should a member continue to provide outstanding service additional awards identified in the RAP manual can be considered.
