11. THE CANADIAN CADET MEDAL OF EXCELLENCE

The Chair introduced this topic as info only. The last round of the manual amendments included a reference to the selection criteria by the Government of Canada and to be followed with an web-link published in the latest Legion Dispatch issue.

Comrade Don spoke on his personal experience as part of the selection process in his Command and the lack of Legion involvement. The Chair cited the background and goal of the medal and reminded that any changes to the present level of limited Legion involvement within the actual selection approval would have to be initiated through the Legion resolution process.

12. MEDALS – NEW PARAGRAPH

The Chair confirmed that the latest RAP manual amendment issues thru the last Legion Dispatch now contained a clear statement as part of Para 121 that prohibit the re-sale of legion medals.

13. PAST OFFICE MEDALS

The Chair mentioned that because of the COVID implications on Branch management over the last two years, some provisions of Section 260 of the RAP manual may have been amended or difficult to implement specifically at some Command and Branch level, but this will not lead to any changes to this section now that most health restrictions have/or will be lifted throughout the country and that normal Legion operation will likely be back to normal.

14. NEW or GENERAL BUSINESS

Comrade John brought back the issue of missing basic information required as part of an award submission and clearly listed in the RAP manual. The suggestion of an additional checklist was discussed, along with the Chair stating that this issue was addressed at the last DEC with a written letter to all Commands asking to improve on their review process for missing information.

The Committee will formally monitor and track the applications over the next six months with the list of any missing information to be compiled. The Committee will then follow that report on what action would be necessary not mitigate this issue going forward.
