#### 3. INFORMATION ITEMS

# a. Veterans Consultation Assembly -

The VCA was hosted at Legion House on 26 October 2024. Key advocacy items were highlighted including the adoption of research on traumatic brain injury, partial entitlements for disabilities and Key financial deficiencies and discrepancies between *Pension Act* and the *Veterans Well-being Act*, including the Marriage after 60 clause under the *Canadian Forces Superannuation Act* (CFSA) that the Minister of Public Safety has responsibility for the *RCMP Superannuation Act* (RCMPSA.) Letter to the Minister is enclosed.

# b. Endorsement of Heroes Mending on the Fly Canada -

A letter of endorsement was sent to the Minister of VAC, providing support for this organization. The therapeutic and positive psychological and physical aspects of fly-fishing is a nature-based intervention that has been proven in numerous studies to help improve the mental well-being of participants impacted by an OSI. Our endorsement included our full support and recommendation for favourable consideration should they apply for fund through VAC's Veteran and Family Well-Being Fund. The letter is attached.

#### c. Women Veterans Council -

A council has been formed and several women with different service backgrounds have been appointed to advise VAC on various issues related to female Veterans. ## g. CIMVHR -

The forum for the Canadian Institute for Military and Veterans Health Research in Winnipeg from 21-23 October 2024. Comrades Berkley Lawrence, Larry Murray, Steven Clark and Charls Gendron attended. Comrade Larry presented the Master's scholarship and Comrade Berkley presented the PhD scholarship to the successful candidates.

# 4. HOMELESS VETERANS/ TPS PROGRAM -

Comrade Dave provided an update that several provincial commands still have not provided quarterly reports on homelessness. Comrade Dave is receiving only about half of the reports at this time.

He provided an update on the Women's Veterans homelessness research occurring across the country carried out by Cheryl Forchuk and her team and noted the continued expansion of TPS.

#### 5. SENIORS -

Comrade George noted that Seniors Support Program – the Home Away Initiative has not been updated for some time and should be reviewed.

Comrade George suggested that the VSS Committee members seek it out on our website and bring forward and comments or notes in next meeting.

#### 6. BSO LEGION OSI SPECIAL SECTION -

Comrade Darren Reid has taken over the position from Comrade Trevor as he moved into the Dominion Vice President position.

Comrade Darren notes the program is busy and updated he is working on creating District Rep's for Buddy Check Coffee, regarding who can be a mentor and work with hosts to expand the program and support in branches.

Progress is continuing with the Rangers program, Operation Northern Vigilance. It is a trial currently. Comrades Darren and Carolyn will be presenting the program to various stakeholders and Ranger commands in the coming months.

Comrade Darren has built a national resource list and would like it to be distributed to the other Provinces and Commands. This is a living document and can be added to it.

Lastly, Comrade Darren thanked Ontario Command for funding a trial peer initiative called Metal for Mindfulness, a Blacksmith program. More news will come as the program expands.

#### 7. VETERANS SERVICES UPDATE

#### a. Postal Strike -

The strike impacted the processing of applications. Urgent claims were actioned immediately with an interim process put in place for the duration of the strike. All dates for retroactivity were protected regardless of the process followed and there were and are no time differences for veterans submitting claims through the Legion.

# b. Service Officer (SO) Training and SO Professional Development (SOPD) –

Comrade Carolyn is looking at dates this spring for SO Training and for SOPD, in the fall, likely to be help at Dominion Command versus Charlottetown as in the past. Further information on this to come as dates are finalized.

# C. Manuge v His Majesty the King Update -

This was a class action on the miscalculation in the cost-of-living increases on monthly pensions. These payments are being directly made into the Veteran's accounts that were impacted by this miscalculation.

#### d. DND and the CAF -

SDAs often have/had burn pits where many different types of contaminated material was burned. The American's now recognizes many different types of cancer and other health concern that could be related to these burn pits.

# 8. ACTION ITEMS - VSSP Applications-

# a. **A.T.H.E.N.A**:

ATHENA is a Health and Well-being Program aims to improve the mental health, physical health and well-being of women CAF veterans through exercise, education and community. It seeks to fight isolation through an online program that is accessible to anyone across the nation. The request is for \$26,300. This has been approved by the VSS Committee to be moved to Poppy and Remembrance for recommendation of funds.

**MOTION**: Recommended this request be moved to P&R for funding.

# b. Mood Disorder Society of Canada:

The MDSC is asking for \$124,900 to continue their existing programs and to increase their support capacities. The funding request would support the following programs: Companionship Calls, Peer Support Workshops, Train-The-Trainer, and Mental Health Resources. ON Command has provided \$75,000 for their Peer Support Program.

The VSS committee would like further breakdown of how the money is being spent, in order to move forward for potential financial support. A review will be conducted by VSS with the updated information.

# C. Canadian Adaptive Snowsports:

They are asking for \$21,705 in funding to reimburse the Training Costs associated to Veterans attending the Invictus Games. 31 Veterans have been chosen in the Snowsport section by Solider On for Invictus 2025. The financial request would provide financial support to Veteran athletes by reimbursing them for their Adaptive Snowsport training and lesson.

VSS would like to know where the equipment goes once paid for and where the funds will go. VSS would like Solider ON and CAD's to be contacted for further information on the funding and program. Once information is provided VSS committee will discuss further
